## International Student Certificate of Financial Responsibility

This certificate is required for all prospective international students whose official residence is outside the United States and is also required before an I-20 will be issued. When completed, the requested information will indicate that sufficient financial funds are available for attending Concordia College. After this certificate and subsequent admission requirements are completed, admission is determined and the student will be notified.

Admission to Concordia College-Selma requires the following:

- Completed Certificate of Financial Responsibility (this form);
- Official documentation of available funds (i.e. official bank statement or brokerage statement) in US currency;
- Completed health form (the health form will be completed by a physician);
- Completed application form with \$25 application fee;
- Official report of academic records with school seal and signature;
- TOEFL Score or equivalent Test of English as Foreign Language.

The costs for attending Concordia College are estimates and subject to change without notification. Because all fees MUST be paid before the beginning of the academic year, the fees must be available in the United States by registration time. If these fees are not paid, you will not be allowed to register and attend classes. This could affect your immigration status.
